## Search for RDC's next General Manager

In September 2021, RDC shareholders and guests were notified that Kathy Wheeler, RDC's General Manager, announced a desire to step back from her role as General Manager, and that a search for Camps' next General Manager would commence immediately.

The notification further indicated that a Search Committee would be established, and that a specialized Executive Search firm would be engaged to source the right candidates for the Committee to consider. Below are details on this process.

Executive Search Firm: The RDC Executive Committee engaged Schrier Wirth Executive Search to conduct the search.
